



Doing Business In The EU/UK

The EU/UK is in an exploratory phase. We have a warehouse and some product on the ground in the Netherlands. The product has been approved for distribution and we are able to ship throughout the European countries as well as the United Kingdom. We have established some pricing and we are set up to take distributor applications and orders. Product will be shipped as it becomes available on a first come first serve basis. Because this is an exploratory phase we are still working through some of the logistics and methods of operation. Product availability and operational functionality will be limited as we prepare for the official opening of these countries.

This is a good time to establish relationships and set up lines of sponsorship. Find leaders that can facilitate rapid growth and assist in organizing systems and models of duplication in order to share this amazing product and opportunity.

Advancement and progression through the compensation plan will be limited until the official launch is announced and product is being delivered and auto ships fulfilled with regularity.

Below are some guidelines on how to get started. All rules and regulations outlined in the Policies and procedures will be applicable and enforced.

1. People may sign up online, via fax or over the phone.

 - a. The current method of sign up is a 4 Case Zpack builder kit and a one or two case Autoship. Upon verification and processing of your order, both you and the enroller have the opportunity to receive a full 30 can sample case of Zija for just the cost of shipping. The sample case is taken from a supply of product that was sent before our new packaging was implemented. We have approximately 500 of these cases in inventory.

This promotion is to remain in effect until this inventory is exhausted.

If the order is placed online, the enroller must request from Zija 1 free case for every enrollee. This may be done via fax, phone, or email to the above locations. The enrollees ID# must accompany each request.

- b. If someone signs up via fax, their address and telephone number must be verified prior to product being shipped out. Verification will be done by one of the Zija team within 48 business hours of receipt of the application.
 - c. Online sign-ups need to only sign up for a business 4pack identified in our inventory as a Zpack. These orders will be fulfilled on a first come first serve basis until our warehouse is fully stocked and processes are in place.
2. Because of the diversity and variable cost of shipping we have priced the product with an all inclusive price structure which includes shipping, tax and duties, and has been divided by regions.
 - a. Region 1 is: Germany, UK, and Netherlands.
 - b. Region 2 is: France, Italy, Romania, and Spain.
